Results	 The ISU's International Judging System (IJS) will be used for all Divisions (except Aussie Skate[™]) and will be open marking. Results displayed or announced will remain provisional until the results are certified by the segment Referee and Technical Controller on the official result form. Aussie Skate[™] will be marked by judges only and will be closed marking. No marks will be available.
Event Officials	Judge/s, Technical Controllers and/or Technical Specialists, Data Operators, Video Replay Operators and Accountants for any scheduled events are by invitation.
Membership Requirements	At close of entries, all competitors must be a full financial member of their relevant State Association and an affiliated club. (Inclusive of ISA Insurance Registration either directly or via their state association). The membership must be valid during the full competition period. Entries must include valid Club and State Membership numbers and POA's number (proof of age).
	 Aussie Skate[™] entrants must be: registered with ISA Aussie Skate[™] and currently enrolled in Aussie Skate[™]; or if in private lessons only (not in the Aussie Skate program), must be a member of ISQ and an affiliated Club. Failure to comply with the membership requirements will result in withdrawal from the event.
