## **1. ANNOUNCEMENT / INVITATION**

## Ice Skating Australia Incorporated and New Zealand Ice Figure Skating Association would like to invite you to participate in the Oceania International Figure Skating Competition 2024.

We would like to take the opportunity to thank the ISU Development Commission for their generous support and for enabling us to conduct this competition and Coaches' Seminar.

## 2. GENERAL REGULATIONS

The **Oceania International Figure Skating Competition 2024** will be conducted in accordance with the ISU Constitution and General Regulations 2022, the Special Regulations & Technical Rules Single & Pair Skating 2022, and the relevant ISU Communications.

Participation in the **Oceania International Figure Skating Competition 2024** is open to all Competitors who belong to an ISU Member and qualify with regard to eligibility according to Rule 102, provided their ages fall within the limits specified in Rule 108, paragraph 3 c) and they meet the participation, citizenship and residency requirements in Rule 109, paragraphs 1 through 5 and ISU Communication 2526 or any update of this Communication.

In accordance with Rule 109 of the ISU General Regulations and ISU Communication 2526 all Skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate. **Passports of all Skaters, as well as the ISU Clearance Certificate, if applicable, must be presented at the accreditation of the event for verification.** 

All competitors must be entered through their respective Member Federation.

### 4. ENTRIES

Members of the International Skating Union and their respective Member Clubs are invited to participate in the competition. Competitors are to be entered by their respective Member Federation.

**Preliminary entries to Oceania International Figure Skating Competition 2024** must be done through the ISU Online Registration System (ORS) by April 30, 20:00 (local time Melbourne, Australia).

#### 4.1 Entries of competitors

Oceania International entries should be made by the Member via ORS.

The entries by name should reach the organiser no later than April 30, 2024.

Confirmation of the skaters accepted to the competition will be published on the website no later than **May 4, 2024**.









#### 4.2 Entry fee

The entry fee is \$150 AUD for Single Programs (Basic Novice and Intermediate Novice) and \$250 AUD for two programs (Advanced Novice to Senior).

Entry fees are not refunded in case of withdrawal after April 30, 2024.

#### 4.3 Entries of officials

Each participating ISU Member is welcome to nominate one Judge and one reserve Judge with at least the qualification International Judge Singles. Please complete the Judges' details in ORS no later than **April 30, 2024.** The panels will be drawn immediately after the closing of entries. Members will be notified of the result.

## 5. MEALS, LODGING and TRAVEL EXPENSES

The organizer will provide and cover the expenses for economy travel, accommodation room and meals for all accepted Officials participating, beginning with dinner on **May 28, 2024** until **breakfast on June 1, 2024**.

Should any Official arrive at the hotel before or stay longer than the period described above, their room costs and expenses will be the responsibility of the individual and must be paid upon arrival. Travel expenses for drawn judges must be covered by the respective member.

All extra expenses incurred by any Official will be the responsibility of that person and must be paid prior to departure. The expenses for rooms and meals for Team Leaders, competitors and other team officials will not be covered by the organizer and are on the account of the team.

The organiser will additionally cover economy round trip airfare for the Referee, Technical Controller, Technical Specialist, and Data/Replay Operators. The Organiser will arrange for transportation from the airport to the Official hotel for all accepted Officials.

## 6. PRACTICE ICE

Unofficial practice for Competitors begins on **May 27**, **2024**. The detailed schedule will be issued at the time of registration. Bookings for unofficial practices can be made via the form on the **www.isa.org.au/oceania2024** 

Practice Sessions will be offered on Monday 27 May, and Tuesday 28 May – Times to be advised. Cost will be AUD \$25 per booking for 1 hour of ice time. <u>Booking link for Practice Ice</u>

## 7. MUSIC / PLANNED PROGRAM CONTENT / PHOTOS

All Competitors shall furnish competition music of excellent quality in digital audio file to be uploaded to the Music/Photo/PPC Jotform and with the music details added to ISU SkaterPortal by **April 30**, **2024**. <u>Oceania Music/Photo/PPC Files can be uploaded here</u>

Competitors must have a copy of their music on a USB with an MP3 file (separate USB's for each event - SP and FS). All USB's MUST be clearly labelled with Skater Name and Event.

The "Program Component Sheet" must be submitted via Music/Photo/PPC Jotform no later than **April 30, 2024**. The Program Component Form must be filled in precisely by each skater in English using the Terminology for the elements listed in the respective ISU Communication.

All competitors are also asked to provide a portrait style photograph (head and shoulders) for possible inclusion in a Souvenir Program. The Photo can be uploaded via Music/Photo/PPC Jotform and submitted no later than April 30, 2024.

## 8. ARRIVAL OF PARTICIPANTS / TEAMS

Invited Officials, Referees, the Technical Panel (Technical Controller, Technical Specialists, Data & Replay Operators), Judges, Competitors, Team Leaders, Team Officials and Coaches taking part in the competition are requested to announce to the Organizing Committee as soon as possible but no later than **April 30, 2024**, the name of the airlines, flight numbers, dates and times of arrival at Melbourne Airport or any other information concerning transportation and arrivals.

#### All Officials will have arranged transport from Melbourne Airport to the Official Hotel.

The nearest airport to Docklands in Melbourne, Victoria is Melbourne Airport (MEL). **Melbourne Airport is** a distance of **21.34kms** to Pearl River Road in Docklands, VIC. The average cost of a taxi from Melbourne Airport to Pearl River Road or the hotel is \$65.00 AUD.

## 9. OFFICIAL HOTEL

The Organiser will make the room arrangements for invited officials only.

Teams, Coaches and Team Leaders and other team members are requested to make all accommodation bookings directly with the hotel. There are many hotels and serviced apartments available in the Docklands area that are walking distance from the O'Brien Group Arena.

The Accreditation is planned at the O'Brien Icehouse upon arrival from **May 29, 2024.** Access to the rink (after accreditation) will be with the Accreditation lanyard given.

## 11. DRAW

The Draw will be held at the O'Brien Group Arena on Monday, May 27, 2024 at 4:30pm in the Bar area on 1<sup>st</sup> floor for all events. For categories with short and free skating – the free skating will be skated in reverse order. The starting order will be made public on the official website.

## **12. PRESENTATION OF MEDALS**

The three best placed Competitors in each event – ISU Oceania International event will be announced and honoured. Gold, Silver and Bronze medals will be presented to the first 3 place-getters.

## 14. INSURANCE / LIABILITY

In accordance with Rule 119, it is the sole obligation of each Member participating, to provide medical and accident insurance for their athletes, officials and all other members of the Member's team. Such insurance must assure full medical attendance and also the return of the ill or injured person to the home country by air transport or by other expeditions. The Organiser will provide emergency medical services for all invited Officials and Competitors during the competition.







## **15. INITIAL JUDGES MEETING/ROUND TABLE DISCUSSION**

The initial Judges meeting and the Technical panel meeting will be held at the ice rink on the evening of May 28<sup>th</sup>. Round Table Discussions will be held on the evenings at the conclusion of each event or at the Referees direction.
